Grants are made at the discretion of the Board, and priority will be given to efforts with the greatest potential for broad impact on public safety.

- (1) Grant applications shall be submitted to the Board in writing no later than January 15 of the then-current year.
 - (a) Grant applications shall include the name of the organization requesting funding, the amount requested, and a description and timing of plans for using the funds.
 - (b) Grant applications shall include a description of the method to be used for program assessment.
 - (c) Grant activities shall be completed by December 31 of the then-current year.
- (2) Grantees, upon completion of grant activities, must will have until January 31 following the completion of grant activities to submit a written follow-up report in letter form to the Board that includes program outcomes based on the planned assessment.
- (3) The Board will review and award grants at a meeting following the grant submission request award grants annually during its February Board Meeting.
